You can also clear the device cache on your computer. To do that, exit any programs that are running (if any), and then open the start menu and go to computer. Hit the keys ctrl + shift + del, this will open a task bar with an option called view c as the only option you will see, then click it and tell it to "show hidden files". It will take a little while, depending on how big your registry is, but once that is done, go to the following folder: C:\ProgramData\Epson\Stylus\StylusPro\ and delete any folder that starts with ip2p. Click "OK" when it is done. Hope this helps. Almost all printers have a reset button, as you point out, but what I meant is the process is quite simple. You need to look in the user manual for your printer to find out which button you need to use to perform a reset.
