Protein kinases are a group of enzymes that catalyze the phosphorylation of specific serine, threonine or tyrosine residues in cellular proteins. These post-translational modifications of proteins can be detrimental or beneficial to the cells depending on the cellular type and the protein kinase involved. In many cases, aberrant kinase activity contributes to the development of disorders such as cancer. A large number of cancer treatments target protein kinases because they act as key regulators of the cell cycle and of cellular proliferation. In fact, these kinases mediate signaling events that lead to abnormal cell proliferation and survival. Although the large number of proteins involved in cancer represent a variety of cellular functions, protein kinases are attractive targets because they are involved in signal transduction processes that ultimately control key cellular processes such as survival, proliferation and differentiation. In particular, cellular signaling pathways such as the RAS/RAF/MAPK, PI3 kinase/Akt and Stat pathways have all been shown to be important in cell

proliferation, survival, angiogenesis and/or metastasis. In addition, the mitogen activated kinase (MAPK) pathway is a serine threonine kinase signaling pathway that plays a central role in the intracellular response to extracellular stimuli. Stimuli such as cytokines, hormones, and chemicals activate MAPK pathways that ultimately regulate cell proliferation, survival, differentiation and development. When activated, MAPK pathways act through a variety of transcription factors including p38/SAPK, ERK1 and ERK2, and JNK. Research on human cancer samples has found that the MAPK pathway is frequently activated and that targeted inhibition of its major effectors reduces tumor cell growth in vitro and in vivo. See, e.g., Pfizer Oncology 2009 Annual Meeting Paper presented by Herbst et al., entitled, “Targeting the MAPK Pathway in Cancer: current status and future prospects.”

p38/SAPK is a protein kinase enzyme that has become one of the most targeted proteins in drug development. The p38 pathway is an important regulator of cell survival and stress response. Also, p38 MAPK activation can be induced by various environmental stresses, including but not limited to cytotoxic agents

and ionizing radiation. Sustained p38 α MAPK expression has been correlated with poor prognosis in melanoma, esophageal and prostate cancer. In addition, there is evidence linking p38 MAPK signaling

After picking up the pieces from a fatal drunk driving crash, the driver is charged with DUI resulting in death of another and operating a motor vehicle without a license. The driver fatally struck a pedestrian in the intersection of Crenshaw Boulevard and Main Street in Ladera Heights on Nov. 20. The victim had placed a leash for her dog at the curb on Main Street in front of a property owned by her family. She was walking eastbound when she was struck by an illegally parked Toyota and died of her injuries. While police were conducting a traffic accident investigation at the scene, officers came across a pair of glasses identified as having belonged to the victim on Main Street. The driver of the Toyota was identified by the victim's family and stopped when police approached. The driver had an invalid license and was taken into

custody. As officers were leaving the scene, they located a wallet with the victim's driver's license in it. The victim's wallet was closed and the driver had placed it in the center console of the vehicle. The victim had no identification and no insurance card in her wallet. The driver was booked and transported to jail. A DMV search confirmed the name and address on the victim's license were valid. From there, it was determined that the driver had been charged previously with DUI in 2013 and had been required to attend an education program as a condition of probation. At the time of the victim's death, she had not been personally charged with an offense. With the DUI, there will now be a third arrest, said LAPD Cmdr. Andrew Smith.
